Can I return outdoor power equipment?

Contact your local store or email [contactus@homehardware.ca](mailto:contactus@homehardware.ca) for more details about warranties on outdoor power equipment. Online Clearance items are considered 'final sale' and are not returnable. Merchandise can be returned to any store at no charge. Merchandise must be accompanied by the original bill of sale.

When can you return an item to Tractor Supply?

You can return an item to Tractor Supply within 30 days from the purchase date to exchange or return it at its original purchase price. Whether you made your purchase in a Tractor Supply store or online, if you're not completely satisfied with any item you purchased from Tractor Supply, return it to us with proof of purchase.

What is Tractor Supply's 30-day return policy?

Tractor Supply's 30 Day Return Policy allows you to return or exchange any item purchased from them, whether in-store or online, within 30 days of the purchase date. You can return the item to any Tractor Supply store or by mail, with proof of purchase, for an exchange or full refund at the original purchase price.

What proof of purchase do I need for a Tractor Supply return?

For store purchases, the cash register receipt or any transactions attached to a customer's neighbors club account serves as proof of purchase for items bought at your local Tractor Supply store. Store returns without proof of purchase or after 30 days from purchase date require refund verification system approval.

How do I get a refund from Tractor Supply?

For items returned to your local Tractor Supply store, refunds are made by crediting the original method of payment if proof of purchase is provided. In some cases, exceptions apply and a gift card or check will be issued. For items returned online, refunds will be processed based on the chart below.
