Where are customs controls performed in the Czech Republic?

Regular customs controls remained in place only along the external frontiers of the EU, therefore, regular customs controls have only been performed in the Czech Republic at international airports.

Are customs checks mandatory in the Czech Republic?

Czech customs authorities limit regular customs checks at external borders as much as possible. Random checks do occur. Checks on veterinary and biological products, for example, are still mandatory. Most customs checks have moved inland from external borders. Includes customs regulations and contact information for this country's customs office.

Can I carry cigarettes out of Prague?

Departing Prague: Should you travel out of Prague to a different country of the EU, you can carry an unrestricted quantity of the majority of items, including tobacco and alcohol, providing they are carried by you and solely for your personal use.

What happens if a commodity is too much in the Czech Republic?

When bringing goods into the Czech Republic, there are limits set on certain commodities. If a certain quantity is exceeded, duty must be paid, and the importer is required to inform customs of the amount of the commodity he or she is bringing into the country.

Can I carry alcohol into Prague?

Travelling to Prague: Should you arrive straight from a different country of the EU, you can carry an unrestricted quantity of the majority of items into Prague, including tobacco and alcohol, providing these are carried by you and solely for your personal use.

How to return money to Czech Republic?

They should produce a receipt bearing the retailer's stamp and an export form at the border and prove that they have the item with them to the customs officer. The money is returned to the customer returning to the Czech Republic at the retailer or Prague Ruzyně Airport through a special company.

It is important to keep in mind that, in many cases, releasing goods from Mexican Customs can take more time than expected. The basic Mexican import document is the Customs Declaration Form for customs clearance (Pedimento de Importación). Mexico requires import and export documentation including a completed pedimento for all commercial crossings.

Good idea. However, you cannot simply bring everything from abroad into Belgium. The customs and excise officers will see to this. They control the import and export of certain goods to and from Belgium. For travellers, this means that you can only import a limited amount of certain goods from abroad, e.g. alcoholic beverages, tobacco or perfume.
