Are there transfer pricing regulations in Laos?

There are no transfer pricing regulations in Laos. The standard rate of VAT is 10%. VAT applies to a wide range of products, including electricity, water, fuel, and all imported products, unless they receive an exemption from the Government of Laos. The top rate of income tax is 24%.
